### Information Regarding the Transactions

Document Type	Document Type 3 or 4
Transaction Date	The date which the transaction occurred
Issuer CIK	The Issuer's CIK
Filer Cik	The Filer's CIK
Director Status	Indication whether the filer is a Director or not
Officer Status	Indication whether the filer is a Officer or not
Ten Percent Owner Status	Indication whether the filer is a Ten Percent Owner or not
Other Status	Indication whether the filer is declared as an Other or not
Officer Title	Each Officer's title given by the SEC filing
Transaction Code	The action for each transaction i.e.. buy, sell, disposed, acquired, automatic buy, automatic sell, options exercised or initial statement of ownership
Transaction Shares	Total amount of shares for the transaction
Transaction Price From	Lowest price for each transaction
Transaction Price To	Highest price for each the transaction
Shares Owned Following the Transaction	Total amount of shares owned by the filer after the transaction occurred
Direct or Indirect transaction status	Indication whether the Transaction was Direct or Indirect
Transaction's Market Value	Market value of the transaction
Total Direct and Indirect Shares Traded	Combined amount of Direct and Indirect shares held by the filer
2 Week percentage gain/loss	2 week percentage gain or loss for Buy and Sell transactions.
3 Month percentage gain/loss	3 Month percentage gain or loss for Buy and Sell transactions.
6 Month percentage gain/loss	6 Month percentage gain or loss for Buy and Sell transactions.
12 Month percentage gain/loss	12 Month percentage gain or loss for Buy and Sell transactions.

### Information Regarding the Roster

Every Filer filing for a company gets a Roster entry. John Doe owns AAA and BBB companies, he will have 2 roster entries. The Roster gets updated every time a filer makes a transaction.

These roster entries can be shown for each person to view their holdings or grouped for each company so you may view the holders or "roster" for the company.
